Dear---

H.R. 7052, now before the subcommitte on Communications for a hearing hopefully will be submitted to the House of representatives for action. It is the purpose of this letter to respectifully solicit your support of this Bill which will place the responsibility for reduction of radio frequency interference on the designers and manufacturers of electronic devices and not the various radio services who operationally comply with FCC regulations.

As an amateur radio operator since ***** (here's where you can get creative) I have been plagued by the interception of my radio signals by electronic devices, such as; TV sets, stereos, hi-fi equipment and radios which were not properly designed to operate in an RF environment. This condition has been a constant source of annoyance to both myself, as a duly license radio amateur, and to my neighter

bors who are users of these devices.

Legislation as provided by H.R. 7052 will not only solve the Radio Frequency Interference problems experienced by radio amateurs but will solve similar problems experienced by other radio services.

A MINI TECH ARTICLE by Ed W6AIN
You think everyone else has got RFI problems? How about
your own station? Maybe you've got power-line interference. Here is a way to tell "what's up":
Some of the common sources of interference and their

sounds are:---

1. Corona: Hissing.

2. Faulty insulators: Buzzing or raspy noise.

3. Hardware noises: popping, staccato, irregular. 4. Loose connections: frying, low-pitched static.

At least so says QST in a July 1970 article, which gives full details.




FCC Relaxations:
