## FCC PROPOSES BAN ON LINEAR AMPLIFIERS

In an announcement on Tuesday, February 15, the FCC released a proposed rulemaking on the banning of the sale or manufacture of any amplifier covering the 24-35 MHz range. Comments will be accepted until April 25 and reply comments until May 5. A copy of the notice can be obtained from ARRL by sending for the "Amplifier Docket" and enclosing a SASE with 24c postage.

Also, the FCC soon expects to release a report and order to be effective 30 days after publication, that will establish spurious and harmonic limits for amateur amplifiers. It would prohibit the sale or advertising of amplifiers which exceed these limits. (Tnx WlAW)


