

Commercial radio telephone exams to be held on the 1st and 3rd Tuesdays of each month from 8:30am to 10:00am.

Amateur exams to be held on the 1st and 3rd Wednesday of each month.

Extra class 20 wpm 8:30am Gen./Adv. 13 wpm 10:30am Tech. 5 wpm 12:30pm Vritten, no code 1:00pm




Hi Gang,
